Whatever costs including postage that might be involved, I will be thrilled to reimburse you or your office in U.S. currency, not Nicaraguan Cordoba's! A simple one line e-mail to me at the above address stating the amount I owe will have those funds sent to you the same day I receive the message.

I realize this is both an imposition, and a bother for your more than busy workday schedule, and if it were not important to young Nathan, I would never ask, so again, please do what you can to help by forwarding my letter and its contents with my sincere gratitude to you for your efforts.
